

# About this Guide

## Introduction

The National Association of County and City Health Officials (NACCHO) funded opportunities in fifteen sites as part of its Implementing Overdose Response Strategies at the Local Level (IOPSLL) program. One of the recipients of the IOPSLL grant is Richmond and Henrico Health Districts (RHHD). This directory aims to increase the knowledge and accessibility of resources for individuals facing substance use disorder (SUD) and mental and behavioral health challenges.

The focus of this guide is to provide a comprehensive detailed list of substance use, mental and behavioral health service facilities in Richmond City and Henrico County within an easy-to-use guide. This tool allows grassroots navigators and community-based case managers to engage with and collaborate care among support service partners to address this public health crisis.

Overdoses have skyrocketed in the City of Richmond and the County of Henrico. For example, the Virginia Department of Health Office of the Chief Medical Examiner Overdose Monitor reported fatal opioid overdoses in Richmond increased three-fold from 2018 to 2022. Henrico saw a doubling in fatal overdoses during the same time-period. Nonfatal opioid overdose rates also continue to rise.<sup>1</sup> Mental illness and substance use disorders often co-occur, which means an individual experiences both conditions (as a dual diagnosis) at the same time. Individuals with mental illness are more likely to experience an SUD than those without.<sup>2</sup> This co-occurrence between mental illness and substance-use disorder is the reason this guide provides resources for both; they are to be considered simultaneously.

Appendix A, the methodology section of the guide, outlines the components of conducting the online research and local networking critical in identifying and authenticating regional organizations. The sustainability plan for the guide is found in Appendix B and describes how this guide will be kept current, accurate and relevant.

# How to use this guide

The RHHD resource guide is comprised of two sections: the educational narrative, and the service directory.

## About the Educational Narrative

The first section is an educational narrative outlining background information, definitions and evidence-based research. This information provides a perspective on elements advancing wellbeing and longevity for persons challenged with substance use, behavioral and mental health issues. Topics included in the narrative are:

- Free clinics
- Mental health and behavioral health
- Harm reduction
- Substance use disorder treatment
- Sober living residences

## About the Service Directory

The second section is an alphabetized directory of local agencies and organizations offering services. Each entry in the directory contains contact and location information, website, and a brief overview of services. Programs are designated as:

- SUD treatment and/or
- Mental health/behavioral health (MH/BH) services

Organizations that are accessible via public transportation (i.e. GRTC transit system) are denoted with **GRTC** beside the address. To be considered GRTC accessible, the facility must be a 10-minute or less walk from a bus stop. A useful GRTC app providing specific route schedules to plan trips is available for download online.<sup>3</sup>

## How to Search within this Guide

If you are searching for a particular treatment or service, such as "Intensive Outpatient," you can search the guide by pressing "CTRL" and "F" concurrently on Windows or "Command" and "F" on Mac and type "Intensive Outpatient" into the search bar that appears.

# Insurance Coverage

The first step in seeking treatment for mental health and/or substance use disorder is understanding insurance status.

**Insured** individuals have some type of insurance coverage to assist in payment of health-related services.

**Uninsured** means the individual does NOT have ANY type of coverage to assist in payment of health-related services. Uninsured individuals may qualify for some of the insurance options listed below.

**Underinsured** individuals have insurance, but it doesn't cover the services or total cost of the care they need. To apply for a new or alternative insurance plan, one should start with the Health Insurance Marketplace.

Insurance coverage falls into the following categories:

- Marketplace
- Medicaid
- Medicare
- Private insurance

## Marketplace

The Health Insurance Marketplace<sup>4</sup> is a federally run platform where individuals can go online<sup>5</sup> or call to compare and apply for different types of insurance plans. The direct contact number for Virginia's Marketplace is 1-888-687-1501.

To be eligible for Virginia's Insurance Marketplace coverage, individuals/households must:

- Reside in Virginia
- Be U.S. citizens, U.S. nationals, or be lawful immigrants during the entire time they plan to have coverage
- Not be incarcerated (unless pending disposition of charges)
- Be uninsured without an offer of affordable employer-based health coverage

## **When you can apply:**

### **Open Enrollment Period**

This is the yearly period from November 1 to January 15 during which you can buy health insurance through the Marketplace or make changes to your existing health plan. If you don't enroll during this time, you can't purchase a health plan until the next Open Enrollment Period—unless you qualify for a Special Enrollment Period.

### **Special Enrollment Period**

A Special Enrollment Period takes place outside the yearly Open Enrollment Period. You can enroll in a health plan through the Marketplace during a Special Enrollment Period only if you experience a Qualifying Life Event (QLE) such as unexpected loss of insurance coverage, a change in your household (marital status, a birth or a death) or change in residence among other situations.

## **Medicaid**

Medicaid covers low-income individuals of all ages<sup>6</sup>. Medicaid is administered by states following federal requirements. Eligibility requirements and benefits vary by state.

### Documents needed to apply:<sup>7</sup>

1. Full legal name
2. Date of birth
3. Social Security numbers (or document numbers for any documented immigrants who need insurance)
4. Employer and income information for everyone in your family (for example, from paystubs, W-2 forms, or wage and tax statements)
5. Policy numbers for any current health insurance
6. Information about any job-related health insurance available to your family
7. Government issued form of identification (e.g. driver's license, passport, military ID card) with at least a birthdate, a photograph and an issue date.

## Medicaid Managed Care Organizations (MCO)

Once you are eligible for Medicaid, you will receive an approval letter and an initial blue and white Medicaid health care card (shown here).

After a short time, you will receive paperwork to choose a specific health plan as your Medicaid care provider. These distinct health plans are called Managed Care Organizations or (MCO's). A Managed Care Organization (MCO) is "a health care company or a health plan that is focused on managed care as a model to limit costs, while keeping quality of care high".<sup>8</sup> An example of a specific MCO card you would receive is shown here.

Medicaid partners with MCOs to provide coverage of healthcare services. The MCO that you choose will determine which doctors, specialists, hospitals, and

medication coverage that will be covered for your health care needs. It is important to contact your MCO directly to inquire about your level of coverage and available services.

## MCO Covered Services

Covered services depend on the carrier or manager of your health insurance as well as the specific plan you are enrolled in. Additionally, covered services in a policy may change periodically. Whenever seeking services, it is always best to contact the organization to verify they accept your MCO coverage.

Many low-income families who don't qualify for other forms of financial assistance can get help specifically for addiction treatment (alcohol, opioid or other substance) through the Virginia Addiction and Recovery Treatment Services (ARTS). ARTS funds cover inpatient detox, residential treatment, partial hospitalization, intensive outpatient programs, substance use disorder treatment programs, office-based addiction treatment, case management, and peer recovery supports. Medicaid provides dedicated ARTS Care Coordinators to help individuals covered by Medicaid connect to addiction and recovery services. These care coordinators are listed on the DMAS page for ARTS.<sup>9</sup>

Table 1 shows some of the most common insurance companies managing MCOs in Virginia and the general mental health or SUD treatment services they cover.

## Insurance & Public Benefit Coverage for Incarcerated Individuals

Another form of Medicaid coverage is insurance for incarcerated individuals. Incarcerated individuals receiving SUD treatment, mental or behavioral healthcare, or medical care can receive necessary services through institutional Medicaid. A case worker or supervisor in the institution can help with this application. Such coverage must change to community coverage in order to start or continue services after release. Due to an administrative delay in the start of converge, this transition should happen prior to release. Otherwise, a delay in treatment services could be detrimental with public health consequences.<sup>10</sup>

Any formerly incarcerated person who did not receive medical or mental health services while under criminal justice supervision will need to apply for medical assistance upon re-entry, through their local department of social services or online at [commonhelp.virginia.gov](http://commonhelp.virginia.gov).

Supplemental Security Income (SSI) are benefits that are based on age, disability and limited income and resources. SSI will award substance use disability benefits *only* with a dual diagnosis (disabling mental or physical condition).

SSI benefits are suspended while an individual resides in a criminal justice facility or institution. However, benefits to their eligible dependents (spouse or children) will continue as long as those family members remain eligible. These funds will be sent directly to the family member in the community.

If disability benefits or SSI payments were withheld because you were in prison, a request for reinstatement can be made at the local Social Security Administration. A copy of your release documents must be provided before the request is completed. For more information see [ssa.gov/pubs/EN-05-10133.pdf](http://ssa.gov/pubs/EN-05-10133.pdf).

Social Security Disability Insurance (SSDI) is similar to SSI. It is an entitlement program for persons who are disabled but, unlike SSI, eligibility requires a work history and prior payroll contributions to social security. SSDI benefits cease during a person's incarceration. All SSDI recipients must reapply after returning to the community, regardless of the length of time their benefits have been suspended. Note that receiving either SSI or SSDI does not always guarantee eligibility to either community Medicaid or Medicare, respectively.

## Medicare

Through the Marketplace, you can also determine if you are eligible for Medicare. Medicare is a federal health insurance program for those 65 and over or those with certain disabilities. Medicare covers some substance use disorder resources under Medicare Part B, as well as mental health services. - Drug testing
- Overdose education

## Private Insurance

Private insurance is often accessed through employment, but an individual can also purchase private insurance on their own. You can shop plans and see which plan best fits your health needs. The plans vary based on cost and coverage. If your employer provides insurance, you may choose to enroll in their plan instead of purchasing a plan on Marketplace. Your employer may provide an Employee Assistance Program, or EAP at no cost (other than a nominal co-pay) to you. An EAP may offer assistance for various substance use treatment services as a private carrier.

## Ryan White Programs

- Under Ryan White HIV/AIDS Program funding: substance abuse (**outpatient**) services which are considered to be medical treatments are included. Nonmedical treatments and/or counseling to address substance use disorder (i.e., alcohol and/or legal and illegal drugs) are covered services *ONLY if provided either by a physician, under the supervision of a physician, or by other qualified personnel in an outpatient setting.*
- Additionally, Ryan White Programs cover essential nonmedical support services. A Ryan White case manager works with the individual's family to arrange client-specific advocacy, education and risk reduction, food bank and meal delivery, short term housing assistance, even perhaps emergency funds as a payer-of-last-resort. Prescriptions, transportation to and from treatment, and legal expenses related to the case may also be submitted.

# Free Clinics

Free clinics are available for individuals that are uninsured and unable to access care through insurance. Free and charitable clinics help bridge a gap in health care coverage, providing services to fit the medical needs of uninsured and underinsured Americans.<sup>11</sup>

Free clinics address disparities in healthcare. These facilities are non-profit organizations supported by federal and local funds or private donations. They are often staffed by volunteers. Free clinics provide an assortment of healthcare services to meet the medical and mental health needs of individuals who might not receive essential services otherwise. Each free clinic is shaped by local need, and no two are the same.

# Organizations for Re-Entry Continuum of Care/Navigation Assistance

The Virginia Department of Corrections (VADOC) provides a comprehensive packet of reentry resources to individuals who are leaving incarceration or under community supervision to assist in their transition.<sup>12</sup> <sup>13</sup> A similar worthwhile reference is the online Community Resources for Probation and Patrol.<sup>14</sup>

Fundamental community services for physical health, mental health, and social well-being are listed. For example, step by step information on gaining employment, health insurance and housing assistance is detailed. However, an initial connection with case management and navigation assistance is strongly suggested as soon as an individual returns to the community. Although Community Service Boards may provide some of these services, they are bound by jurisdictional boundaries.

For both Richmond City and Henrico County, the recommended place to start is with **O.A.R. Richmond**, an organization already familiar to many due to the organization's participation in re-entry planning inside each of these criminal justice centers.

# Mental Health and Behavioral Health Services

The terms “mental health” and “behavioral health” are often confused but actually have different frames of reference.

## Mental Health

Mental health is “our emotional, psychological, and social well-being. It affects how we think, feel, and act.”<sup>15</sup> Mental health can be influenced by various factors like life events, genetics, environment, or daily habits.<sup>16</sup> Mental health disorders include bipolar disorder, anxiety disorder, schizophrenia, psychosis, and more.

Mental health treatment focuses on:

- Reducing symptoms
- Addressing underlying causes
- Make the condition manageable

## Behavioral Health

Behavioral health<sup>17</sup> refers to:

- Mental health
- Substance use disorders
- Life stressors and crises
- Stress-related physical symptoms

Behavioral health programs focus on:

- Diagnosis
- Evaluations of how the actions a person takes affect their physical or mental health
- Treatment of conditions
- Prevention

Although mental health and behavioral health have different focuses, they are often addressed together in programs, especially with SUD treatment services.

# Harm Reduction Services Including Naloxone

The SAMHSA, Substance Abuse and Mental Health Services Administration, defines Harm Reduction as: "an evidence-based approach that is critical to engaging with people who use drugs and equipping them with life-saving tools and information to create positive change in their lives and potentially save their lives."<sup>18</sup>

Harm reduction is a key pillar in the U.S. Department of Health and Human Services' Overdose Prevention Strategy.<sup>19</sup> Harm reduction aims to improve a person's overall wellbeing through preventing overdose and other health consequences of substance use. Harm reduction can decrease the spread of HIV, Hep C, and endocarditis, saving lives while significantly reducing community and individual healthcare costs.

## **Harm reduction programs may include:**

- Educational materials
- Needle exchange
- Narcan<sup>R</sup> training and distribution
- Nutrition provisions
- Safe-sex tools
- Saline and wound care kits
- Fentanyl and Xylazine test strips
- Nicotine cessation therapies, and more

These services are community-based and often distributed without charge from mobile units. Educational materials are provided along with these tools and supplies for risk reduction are distributed in a stigma-free environment.

There may be registration required for some services. Some facilities/organizations listed in the guide may have age restrictions for distribution of some items and medications (ex. Narcan or some sex kits).

**Narcan<sup>R</sup>, or Naloxone** (generic name), is the single most effective means to reverse an opioid overdose. It can be life-saving. When given, it counters the effects of an opioid overdose so normal breathing can resume.<sup>20</sup>

The most common way Naloxone can be given is through a nasal application. Learning the signs of overdose is critical. It is recommended to have Naloxone on hand wherever opioids are available and/or used. When giving Naloxone, individuals should contact the suicide and crisis chat hotline by dialing **988** and stay with the person until emergency crews arrive.

Whether looking for precautionary measures against overdose or for immediate assistance, contact **Never Use Alone Hotline** at (804) 484-3731. Confidential Operators stay on the phone with you while you use, and if necessary, initiate recovery actions.

**Test strips** are chemically sensitive strips of paper used to detect the presence of specific **contaminants** (like fentanyl or xylazine) in a drug. Knowing the presence of contaminants can help individuals take steps to reduce their risk of overdose.

It is important to note that test strips do not work in all cases. One portion of a drug may contain contaminants, while another portion may not. Test strips don't tell you the *amount* of contaminants in a compound, just the presence. - Pharmacies – Over the counter, prices vary, call for availability
- Local community organizations (reference directory) – Call for availability

## **Ways to Access Test Strips**

- Local health department and community services boards
- Police department

## **Harm Reduction Education and Training Opportunities**

Naloxone can be administered by anyone in the community. It is **highly** recommended to complete an appropriate education and training on the proper use of Naloxone.

Table 4 indicates where individuals can receive training on harm reduction and Naloxone. Facilities in the table provide educational and/or material resources, but not always direct services.

## Substance Use Disorder (SUD) Treatment

Recovery is a process of change through which individuals improve their health and wellness, live self-directed lives, and strive to reach their full potential.<sup>21</sup>

This process begins with seeking help and support. Support may be in the form of medication management, various counseling techniques, peer recovery relationships and developing skills to transition into a healthy home and community. Co-existing conditions, including polysubstance use and the dual diagnosis of mental health issues and substance use disorder, must be addressed.

SUD treatment centers offer a variety of programs including medically managed withdrawal, detoxification, treatment programs, and aftercare for one's recovery journey. Treatment centers may offer outpatient and/or in-patient services including residential programs.

## SUD Treatment Facilities

A treatment center is an accessible and integrated facility for evidence-based clinical best practices. Providers team with the client, contributing to an effective person-driven, individualized treatment plan. These coordinated multi-disciplinary programs, when available, have the best results for retention and sustained recovery; however, all organizations referred to as “substance use disorder treatment centers” do *not* provide integrated services. These facilities often collaborate with reliable referral sources in the same community for the services their programs do not provide.

The American Society of Addiction Medicine (ASAM) is an organization that uses the Commission on Accreditation of Rehabilitation Facilities (CARF) to rate facilities by their level of services in the continuum of care for SUD programs.

Some organizations in this guide highlight their rating on the ASAM scale, while others do not. The ASAM scale is important to note during the patient referral process as it indicates the level of services offered. The ASAM website<sup>22</sup> offers an overview of the rating system. Each level has intermediate benchmarks as well, and this scale is continuously updated.

Among the most common programs in SUD facilities are two levels of initial treatments: Intensive Outpatient Programs (IOP) and Partial Hospitalization Programs (PHP). Aspects of the two types of programs are outlined below:

### Intensive Outpatient Programs (IOPs)

- Offers greater schedule flexibility, with time slots available in the morning, afternoon, or evening
- Sessions last a few hours per day, a few days per week
- Last 6-8 weeks in total
- May be an initial program or a transitional one, allowing not only living at home instead of in rehab (as does PHP, also) but allows time for family routines and some employment commitments

### Partial Hospitalization Programs (PHPs)

- Involves medical monitoring and intensive therapies, including medication management, individual therapy, and group therapy
- Sessions last up to 8 hours per day, at least five days per week

- Last weeks to months in total
- Offers more support from rehabilitative staff
- Often a step-down from residential or inpatient programs
- Generally medically monitored, co-existing diagnoses may be addressed via multiple forms of counseling and therapies

## Medication Assisted Treatment (MAT) or Medications for Opioid Use Disorder (MOUD)

Recently, MAT has been more accurately termed "Medication for Opioid Use Disorder" (MOUD) to better describe a *comprehensive and integrated recovery* program consisting primarily of medications prescribed by a physician to prevent cravings, withdrawal symptoms and harm from opioid side effects.

MOUD describes programs with an integrated approach. Dispensing medications for opioid use disorder takes place in conjunction with counseling, resource guidance and other supporting measures. However, due to stigma and individual preferences, some individuals will forgo one or the other service track and work a recovery plan that is less comprehensive. Evidence-based research demonstrates medication alone is the most significant component of recovery; however, the best results for sustained recovery are when medication is paired with counseling and behavioral therapies.<sup>23</sup> Ideally, a "whole patient" approach for those seeking recovery finds all three components:

- MOUD (with counseling)
- Case management with a warm handoff to community-based wraparound services
- Peer and patient navigation for healthy relationships and community<sup>24</sup>

Comprehensive MOUD treatment programs promote:

- Retention
- Recovery
- Patient survival

Those who complete MOUD treatment programs successfully have increased employment opportunities as well as improved maternity outcomes for pregnant individuals.<sup>25</sup> Individual clients may not match every program; within the Richmond and Henrico Health Districts, there are several exemplary models. Overall, the districts have a combination of comprehensive, integrated collaboratives and single entities across the board.

Methadone, the oldest form of MOUD, has been routinely available since the 1970s. It is the most thoroughly researched treatment for SUD. As the chart below illustrates, newer medications and combinations of medications have some advantages such as decreased dosing frequency, lesser different side effects and resultant increased program retention.

“One size does not fit all.” Any complexities or contraindications for a particular drug choice due to a client’s co-existing conditions and medications can be addressed in an individualized MOUD regimen.

In order to be licensed to manage patients in an MOUD program, the FDA requires clinicians to complete special training, maintain their certifications, and dedicate a minimum portion of their practice office hours to patients with SUD. Additionally, the FDA closely monitors physician participation and may make unannounced site visits. To find practitioners who have those credentials, see [asam.org](http://asam.org).

## Sober Living Homes/Recovery Residences

Sober living homes (SLH), also known as recovery residences are alcohol and drug-free housing. They serve to create safe and healthy living environments for individuals recovering from substance abuse disorder or co-occurring mental illnesses.<sup>26</sup>

Services can range from peer-support to counseling to clinical services. SLH also vary in the level of supervision and administration of services. These residences in Virginia are accredited by the Virginia Association of Recovery Residences (VARR) and provide various services to residents based on the level of support offered.<sup>27</sup>

Individuals can use various websites to search for recovery residences as well as current vacancies, shown in the table below.

## Virginia Association of Recovery Residences (VARR)

### About VARR

VARR stands for the Virginia Association of Recovery Residences and is Virginia's National Association of Recovery Residences (NARR) accredited body. VARR sets "high levels of standards for quality recovery residences in Virginia and accredit residences that meet such rigorous criteria in order to support persons in recovery with information and access to recovery residences bound together by the core principles of standards, ethics, and unity."<sup>28</sup>

### VARR Standards

Recovery residences must adhere to the NARR Code of Ethics to be a VARR Accredited Recovery Residence. The Code of Ethics can be found online<sup>29</sup> and includes some standards such as assessing potential resident's strengths and needs and determining whether the level of support available within the residence is appropriate, assisting residents through referrals, providing a homelike environment, protecting the privacy, confidentiality, and personal rights of each resident, providing an environment where each resident's recovery needs are primary factors in decision making, and more. NARR defines 4 recovery residence levels of support (level I: peer-run, level II: monitored, level III: supervised, and level IV: service provider) with specific standards criteria for each level.

## Oxford Houses

Oxford houses are a distinct types of recovery residences that are self-governed substance-free with no on-site staff. These houses are gender-specific and are long-term housing options without a time-limit on duration of stay.<sup>31</sup> They provide a space for individuals to gain self-reliance and leadership skills while living amongst peers in a safe, supportive recovery environment.





# Appendix A: Methodology

The purpose and goals of the resource guide were initiated by the NACCHO IOPSLL grant. The objective of this grant was for Richmond and Henrico Health Districts (RHHD) to implement a community-led, culturally responsive strategy to reduce overdose and SUD-related morbidity, mortality or associated harms. Strategies must reflect the needs of the community and be evidenced based, or evidence informed.

The Richmond Henrico Regional Resource Guide to Substance Use, Mental and Behavioral Health was developed to address the need for an updated source for education and a listing of community resources related to substance use, substance use disorder or overdose prevention. Embedded in the guide is an A-Z directory of all of the community resources. The guide also includes an introductory educational narrative and instructions on how to utilize the directory.

The team that developed this guide was recruited and overseen by the Director of Community Programming at Richmond and Henrico Health Districts (RHHD). The team hosts a variety of expertise to include a Social Worker and Community Advocate, a Public Health Professional and an Epidemiologist with coalition-building experience.

This team fondly known as the IOPSLL Resource Mapping Team, worked from October 2023 through the summer of 2024 on this project. Below you will find the methodology and steps followed to create the Richmond Henrico Regional Resource Guide to Substance Use, Mental and Behavioral Health.

## FALL 2023

### **Group Convening, Introduction to Partners:**

Convening in early October of 2023, the core team members met to become acquainted with individual backgrounds and strengths prior to formally meeting with the Director of Community Programming. The four spent several early sessions discussing goals, deliverables, tasks and the timeline for the project.

The team was introduced to multiple RHHD colleagues in various roles and settings such as: Community Health Workers that work in our Resource centers, our Substance Use outreach team, clinical staff and leadership.

The Mapping Team was able to engage with our other two local IOPSLL partners to discuss the resource guide project and its potential to improve service delivery. The team met with NoLefTurns and A Better Day Than Yesterday. Both agencies support individuals in the community that are often dealing with SUD. NoLefTurns provides re-entry services for individuals transitioning back into the community after incarceration and A Better Day Than Yesterday, partnered with RHHD to host and facilitate community conversations. Community conversations were community led conversations that focused on the lived

experiences of residents and provided a space to express the reality of the gaps in services and barriers to SUD and MH/BH treatment.

In November 2023 the team participated in a valuable virtual meeting that was organized by our NACCHO and New York Department of Health & Mental Hygiene partners. This meeting included several IOPSLL-grant site partners. These sites were also working on resource guide projects. The sites represented were Marion County, IN, Wyandotte County, KS and Forsyth County, NC. This collective, participated in an extended discussion of methodology, lessons learned, sustainability plans and website options for their resource guides. It was an enlightening discussion and shared learning about the challenges and successes in developing, maintaining and disseminating a community resource guide.

Lastly, they participated in multidisciplinary task forces such as, the Virginia Office of Substance Abuse Prevention (VOSAP) and the Richmond City Justice Center's Public Policy Forums.

### **Research:**

Throughout the fall, the team continued to familiarize themselves with the landscape of local, state and national organizations while simultaneously developing an understanding of data driven, evidence based best practices and federal mandates and regulations. The team conducted field visits during the fall which included recovery homes and service-providers in a variety of settings.

Members continued to perform both scholarly and pragmatic literature reviews and participated in synchronous and asynchronous webinars to expand their knowledge of social needs and best practices. The team researched the evolution of harm reduction practices as well as learning about the components of successful recovery programs

An important component of research was the review of multiple directories that were already in existence. The comprehensive guide and its component A-Z directory were created largely through online research, initially referencing the 2018 version of the Richmond Henrico Substance Use Community Resource Guide: Richmond and Henrico Health Districts ([https://www.vdh.virginia.gov/content/uploads/sites/119/2018/10/Substance-Use-Treatment-for-web-Resource-Guide\\_Apr2018-1.pdf](https://www.vdh.virginia.gov/content/uploads/sites/119/2018/10/Substance-Use-Treatment-for-web-Resource-Guide_Apr2018-1.pdf)).

Also of interest were multiple public resource guides created by organizations such as the Virginia Department of Corrections (VADOC) and Richmond Behavioral Health Authority (RBHA).

### **Search terms and websites used:**

The following sites were used for research: Bounce Back from Addiction ([bouncebackhc.com/treatment](https://bouncebackhc.com/treatment)), SAMHSA's [FindTreatment.gov](https://www.findtreatment.gov), and Psychology Today's directory of providers ([psychologytoday.com/us/treatment-rehab/va](https://www.psychologytoday.com/us/treatment-rehab/va)), were most used.

Once local organizations were identified, the organization's website was the main source of information for this resource guide. Information was collected for each organization including website, contact information, hours, address, GRTC accessibility, program name and type of program, insurance, clients served, and services provided. Local organizations included in this guide were contacted via phone and/or email and given an opportunity to provide corrections or additions regarding specific information on their services.

### **Taskforce Feedback:**

In addition to this feedback, preliminary drafts of the guide were delivered to the Richmond Opioid Taskforce to solicit more comments, additions, and corrections for the material and format. Personal contacts and relationships were made through online and in-person meetings.

Although much of the initial work was done individually, collaborative team meetings happened weekly at a minimum. With guidance from the Director of Community Programs and the preliminary feedback from task forces and other committees, parameters such as the categories for data collection and scope of programs were refined. Progress on the timeline of the project was periodically provided as updates during departmental and task force meetings.

## **WINTER 2023-2024**

### **Development of the Guide:**

In-depth development of the A-Z directory portion of the guide began. Throughout the winter months, the data was compiled and verified for near-one hundred initial listings.

The information detailed in the directory includes the following:

- Website
- Contact information
- Hours
- Address
- GRTC accessibility
- Program name and type of program insurance

- Clients served
- Services provided

During the development of the directory, the Mapping Team reached out to conduct virtual and in-person introductions to key organizations in the area. Meetings were taken with many of the organizations listed in the directory. The team reached out to local and regional carceral facilities, Richmond Behavioral Health Authority which is the local community service board, staff with the drug and mental health court diversion dockets, leaders in harm reduction efforts and recovery programs of all types. These ranged from hospital detoxification settings to long-term transitional residential situations. The team members individually spoke with staff in different roles such as: managers, intake agents, case management workers, Peer Recovery Specialists, family members and allies of people who use substances, survivors of overdose, clinicians, parole officers, persons in recovery, past and present re-entry coordinators and others.

It is important to highlight that several local programs were inspired by the lived-experience of peers or allies while others were campuses installed by multistate service-providing corporations. Some facilities were long standing while others were recently coming online. Anticipation of the directory and the importance of its sustainability were evident with each encounter.

During this quarter, the team participated in trainings and subsequent workshops of the Unite Us E-referral platform. The team also attended a group tour of the Richmond City Community Resource Centers.

### **Communications:**

Formatting and editing of the guide were the next stages of development. The team began meeting with the districts' communication director for context regarding the optimal formatting of a readable, sustainable end-product. The result of the support and collaboration with the Communications Team from that meeting forward has resulted in the polish and presentation of this guide.

### **SPRING 2024**

The third quarter brought more frequent and focused team meetings with a key member of the communications group.

Work continued on the formatting, editing and preparation of the guide itself. Time was spent developing the introductory narrative that includes comments about the purpose of the document. This narrative also breaks down terminology, themes and categories of substance use disorder that are important for readers to understand as they use the guide.

Time was devoted to the delineation of how the guide and its component directory would be searchable, creating and refining a glossary, table of Contents and Index as well as appendices found (methodology and sustainability). Again, the communications consultant was invaluable in developing the format for each segment and cultivating the optimum presentation of the end product.

These late-term meetings also included the perspectives of the Substance Use Coordinator and other members of the Richmond Opioid Task Force, the Clinical Social Work Supervisor, and lead on the districts' Resource Guide in Community Programs which was finalized just prior to this resource.

Several group sessions were devoted to the most feasible sustainability protocol, the logistics and role players. The next steps in the roll-out and the direction of imminent expansions of the scope of the guide paralleled the teamwork during these final months.

## **SUMMER 2024**

The final stages of this project were focused on discussing the language and formatting of the methodology and sustainability plan as well as final formatting of the entire guide.

Work continued with the communications team to upload the guide to the RHHD website and also the RHHD internal Taskforce, Henrico Addiction Taskforce and other community partners. The communications team resource channel. The team has disseminated the final copy to the Richmond Opioid will also be printing a limited number of physical copies.

The IOPSLL Mapping Team spent the month of September presenting the completed guide to RHHD staff and will look for opportunities to present to the larger VDH staff, community partners. The project came to a close September 2024.

Sustainability is *essential* to maintaining the relevance and effectiveness of this guide. Because of the constantly changing landscape of the resource environment, this guide will require continuous updating with real time maintenance to ensure its ongoing validity, accuracy and effectiveness.

This sustainability guidance outlines the general steps that should be taken to maintain the guide. It is recommended that this guide have a comprehensive review annually. It is of the utmost importance that this responsibility is assigned to dedicated staff.

Updates and additions to the guide should be addressed as they are discovered. We have created the ***Richmond Henrico SUD Guide Agency/Organization Update Form***. This form will be posted on the RHHD website and can be used by anyone to submit an update to a directory entry or to submit a request that a new entry be added.

# Glossary

**12-step programs:** A global community of people who come together to work towards solutions and support for one another regarding substance use, abuse and dependence. It does not cost anything to attend meetings, which are organized locally at designated meeting places and times. There are no age or education requirements, or registrations necessary to participate; individuals are met where they are, often with a language or culture-specific atmosphere. A foundation of these organizations is to accept each other and help achieve and maintain sobriety. In addition to “working the steps,” this is accomplished through fellowship, peer counseling and celebrating each other’s achievements. Each group may have a unique benefit regarding language, culture or characteristic atmosphere.

For example, **Alcoholics Anonymous (AA):** [Find A.A. Near You | Alcoholics Anonymous \(aa.org\)](#), <http://aa-intergroup.org>. Information about sister organizations can be found at [Al-Anon Family Groups](#).

Similarly, **Narcotics Anonymous (NA):** groups provide help from peer a network for persons who use drugs and wish to pursue and sustain a drug-free lifestyle. NA’s approach makes no distinction among substances including alcohol. The link [NAWS : Find a meeting](#) can be used for worldwide reference. There is also an app in Google Play or The Apple Stores.

Additionally, there are 12-step groups organized for allies and family members of individuals dealing with substance use issues. These mutual aid associations validate members as well as assist with the dynamics of their relationships with their loved ones. Information about meetings and focused groups can be found at the site <https://www.nar-anon.org>.

**Addiction and Recovery Treatment Services (ARTS):** Medicaid expansion has provided additional services for members with substance use disorders across the commonwealth of Virginia. ARTS covers inpatient detox, residential treatment, partial hospitalization, intensive outpatient programs, opioid treatment programs, office-based addiction treatment, case management, and peer recovery supports. ARTS programs are certified and licensed by the Virginia Department of Behavioral Health and Developmental Services (VDBHDS). ARTS provides treatment for those Medicaid, FAMIS, and FAMIS MOMS members with a substance disorder across the state of Virginia.

**American Society of Addiction Medicine (ASAM):** Professional medical society for addiction medicine professionals and the educational resource for certification, recertification, or those interested in specializing in addiction medicine to prepare for certification exams. They credential clinicians as necessary for treatment centers.

**Behavioral Health:** According to the American Medical Association, behavioral health “refers to mental health and substance use disorders, life stressors and crises, and stress-related physical symptoms. Behavioral health care refers to the prevention, diagnosis and

treatment of those conditions." ([What is behavioral health? | American Medical Association \(ama-assn.org\)](https://www.ama-assn.org/what-is-behavioral-health))

**Capacity:** Generally, the number of beds available in a residential setting. This would limit the number of occupants who could be housed at that location at any one time. Similarly, a small agency may limit the number of clients they can serve at once. The term "capacity" may be used to describe either the gross number possible or the net number available or "open" at the time of inquiry.

**Case Management:** Coordinated approach to connecting clients to appropriate services for their needs – health, substance use treatment, mental health and social services.

**Certified Community Behavioral Health Clinics (CCBHC):** Follow strict criteria. Richmond Behavioral Health Authority (RBHA) is currently the sole CCBHC for the Commonwealth of Virginia. CCBHCs certify coordinated comprehensive behavioral health care, substance use disorder programs and ensure the use of evidence-based practices.

**Contaminants:** A contaminant is a substance that pollutes, spoils, or poisons something. Fentanyl and xylazine are two common examples of contaminants that are added into street drugs. These contaminants potentially alter the potency and increase the risk of harm.

**Continuum of Care:** the span of care across prevention, diagnosis, the array of treatment regimen, and retention in substance use treatment.

**Co-occurring Disorder:** [Co-Occurring Disorders | Psychology Today](https://www.psychologytoday.com/us/conditions/co-occurring-disorders) Typically describing the situation where an individual is challenged by both mental illness and SUD, this term may also apply to other combinations of conditions making treatment plans more complex. For example, a disability or other chronic disease might compromise medication options.

**Detoxification/Detox:** Specifically, when used in this document, this implies "medically monitored withdrawal." In general, the term describes the period, and the associated symptoms when the substance or drug is being eliminated by the body. Physical effects can be intense, and medicines may be able to ease those temporary symptoms. Unmonitored and unaided, an individual could conceivably die from severe withdrawal.

**Dual Diagnosis:** Condition of having simultaneous mental health and substance use disorder

**Evidence-Based Practice:** Interventions that are guided by the best scientific research evidence with practice-based expertise, shown to provide the most reliable outcomes to date for individuals.

**Harm Reduction:** a set of practical strategies, ideas and programs aimed at reducing the negative consequences associated with substance use. Based in social justice and human rights, these practices or supportive services can save lives, reducing the risk of overdose, disease transmission and other health issues.

**Insured individuals** have some type of insurance coverage to assist in payment of health-related services. This may be a private carrier or government assistance such as Medicare or Medicaid.

**Intensive Outpatient Program (IOP):** Treatment program that allows the patient to live at home while going into an office to receive structured treatment plan daily or weekly 3-4 hours a day.

**Medically managed withdrawal:** Detoxification under medical supervision administering progressively lower doses of medication during the time a patient has abruptly reduced or ceased the use of a substance to which they have developed a tolerance.

**Medication Assisted Therapy (MAT):** More recently accurately termed "Medication for Opioid Use Disorder" (**MOUD**) describes a *comprehensive and integrated recovery* program. This includes counselling, behavioral therapies, and a craving-suppression medications prescribed by a physician to prevent withdrawal symptoms, and harm from opioid side effects. Evidence-based research demonstrates medication alone MAT/MOUD as the most significant component of recovery; however, it is more effective combined with a comprehensive program.

**Mental Health:** According to the Centers for Disease Control and Prevention (CDC), mental health is "our emotional, psychological, and social well-being. It affects how we think, feel, and act."

**Mental Illness:** Mental illnesses are diseases or conditions that affect how you think, feel, act, or relate to other people or to your surroundings <https://www.mayoclinic.org/diseases-conditions/mental-illness/symptoms-causes/syc-20374968>

**Mobile Treatment Services:** Innovative approach to bridging gaps or obstacles to access by going directly into the community. These are often used in rural areas as well as for persons who are unhoused. In addition to MOUD, these programs might include therapist, mental health professions and peer support as well as the distribution of harm reduction supplies.

**Mutual Aid Strategy:** Self-directed programs or peer led sessions where members work together to meet the needs of everyone in the group or community. These may follow a conventional program and/or be a drop-in group. Among such community-based support groups are 12-step programs like AA, but mutual aid groups may also be less traditional programs which are religious (faith-based), or secular such as SMART Recovery.

**Office-based Opioid Treatment (OBOT) or Office-based Addiction Treatment (OBAT):** may include medications for SUD as well as integrated counselling and therapies similar to SUD treatment facilities but based out of a practitioner's office.

**Opioids:** A class of substances that have effects similar to opium by binding to the opioid receptor in the brain, producing euphoria and decreased pain among other effects.

Natural, semisynthetic, or synthetic opioids may be legally prescribed in some instances but are largely misused and quite addictive.

**Opioid Treatment Programs (OTP):** a federal government certification that SAMHSA describes the criteria as well as lists the dozen or so organizations in the Greater Richmond area which have obtained it on the [FindTreatment.gov](https://www.FindTreatment.gov) website. (This is similar to the CCBHC certification.)

**Partial Hospitalization Program (PHP):** Treatment program that includes IOP but more intensive, where treatment is all day, but patients can go home at night.

**Peer Recovery Specialists (PRS):** These are trained (and certified) individuals with lived-experiences such as challenges within the criminal justice system or struggles with substance use, mental and/or behavioral health disorders in their past. They have demonstrated their own successful recovery journey and can provide understanding, respect, encouragement, and guidance connecting others to social support and treatment services. Community based PRSs may well be the singular initiation to a recovery path. They reach individuals where they are at the time they are ready to change.

**Polysubstance Use Disorder (PUD):** a condition that develops from **long-term use or misuse of 2 or more substances**. It includes use/misuse of drugs such as cocaine, alcohol, tobacco, or prescription medicines such as opioids.

**Recovery:** The ongoing process of change through which individuals improve their health and wellness, live self-directed lives, and strive to reach their full potential. It is important to note that recovery is not a universally defined “end point.” This term could be used for mental health disorders, substance use disorders, or other chronic conditions.

**Re-entry:** The transitional period of a person leaving incarceration and reuniting with the community.

**Relapse (return-to-use or re-occurrence):** Describes a person’s resumed use of a substance after experiencing a period of sobriety.

**Sober Living Homes (SLH) or Recovery Residences:** Alcohol and drug-free housing that serves as a safe and healthy living environment for individuals recovering from substance abuse disorder or other co-occurring mental illnesses.

**Stigma:** A bias, often value-laden language, by which people are stereotyped, devalued, labeled, and excluded from equitable access to community resources. Stigma creates feelings of disgrace, self-reproach and other negative self-image as well as presenting false barriers to treatment, social services and other resources.

**Substance Use Disorder (SUD):** Treatable chronic disorder that affects a person’s brain and behavior, leading to their inability to control the use of a substance despite the harmful physical, psychological and social effects from continued use.

**Social Security Disability Insurance (SSDI):** Social Security Disability Insurance (SSDI) is similar to SSI. It is an entitlement program for persons who are disabled but, unlike SSI, eligibility requires a work history and prior payroll contributions to social security. SSDI benefits cease during a person's incarceration. All SSDI recipients must reapply after returning to the community, regardless of the length of time their benefits have been suspended. Note that receiving either SSI or SSDI does not always guarantee eligibility to either community Medicaid or Medicare, respectively.

**Supplemental Security Income (SSI):** Supplemental Security Income (SSI) are benefits that are based on age, disability and limited income and resources. SSI will award substance use disability benefits *only* with a dual diagnosis (disabling mental or physical condition).

**Sustainability:** A goal using adaptation and effective prevention measures to achieve and maintain long-term results.

**Test strip:** They are chemically sensitive strips of paper for testing a sample of a drug before using it, to raise awareness and risk of specific contaminants such as fentanyl or xylazine. Test strips are an example of harm reduction materials.

**Trauma-informed Care:** A treatment approach recognizing the symptoms of broad and cumulative mental and emotional effects of multiple kinds of trauma. Consideration of the history of earlier trauma avoids re-traumatization during treatment.

**Underinsured:** These individuals carry some insurance (private or government program). However, their out-of-pocket healthcare expenses (deductible plus any copays) exceed a threshold proportion of their annual income. Their plan is inadequate for their need.

**Uninsured:** Individuals do NOT have ANY type of coverage to assist in payment of health-related services. Uninsured persons are not enrolled in government programs, employer-offered insurance plans, or any private insurance carrier.

**Virginia Alcohol Safety Action Program (VASAP):** Programs providing education and probationary oversight to offenders who have been referred from a court, typically for a conviction of driving under the influence (DUI).

**Virginia Department of Behavioral Health and Developmental Services (DBHS):** Department of the state government which provides accreditation, networking, and oversight for agencies and organizations delivering services during public emergencies, to persons needing behavioral health care, or to persons with developmental disabilities or substance use disorder.

**Withdrawal:** A combination of physical and mental symptoms a person experiences after they stop or reduce the use of a substance such as alcohol or other addictive substances.
